# Manufacturing process and chemical composition

# Manufacturing process:

Esterification of Ethylhexyl alcohol (produced from coconut oil through hydrolysis, filtration, hydrogenation and a fractional distillation) with Salicylic acid (synthetic origin). Followed by the steps of filtration, bleaching, deodorisation and neutralization. After the quality control the ester is then filtered and packed.

Maximization tests of Ethylhexyl Salicylate produced no sensitization in guinea pigs. Salicylic Acid is not photosensitizers.

In clinical tests, Salicylic Acid (2%) produced minimal cumulative irritation and slight or no irritation(1.5%); Ethylhexyl Salicylate (4%) produced no irritation.

In normal skin, Salicylic Acid and Ethylhexyl (Octyl) Salicylate are not sensitizers. Salicylic Acid is not a photosensitizer, nor is it phototoxic.
